I agree to hold AYC, ASF, and their representatives blameless and save them from any expense or claim that may arise from injury or damage while the boat is in my possession, including any attorney's fees, court costs or other reasonable expenses as a result of legal action resulting from damage or injury.

Adopt-a-Boat Use & Safety Addendum

- (Initials) _____ while borrowing an Adopt-a-Boat I'll wear a properly fitting USCG-Approved Type I, II, III or V Personal Floatation Device (PFD) in good condition at all times near the water.
- (Initials) _____ Adopt-a-Boats may not be operated:
 - In wind velocities of 15-mph or higher. If a white light is flashing on any of the three Tempe Town Lake Emergency Warning System poles located around the lake, boats may not be launched, and if already underway, boats must return to the dock for haul-out and storage.
 - Anywhere other than Tempe Town Lake.
 - At anytime other than during scheduled AYC races at Tempe Town Lake.
 - After sunset.
- (Initials) _____ Height Restricted Areas in the roadways around the Tempe Town Lake Boatyard have been shown to me. I understand that rigged boats on trailers must not attempt to pass under the restrictions. Attempting to do so will result in possible injury to people nearby and damage to property.
- (Initials) _____ Adopt-a-Boats may only be used during AYC Race Events at Tempe Town Lake. I agree to REGISTER to race my Adopt-a-Boat before the first race date following my approval to use an Adopt-a-Boat.
- (Initials) _____ I will be aboard and in-charge of my assigned Adopt-a-Boat at all times the boat is underway. My assigned boat cannot be loaned or used by others.
- (Initials) _____ I will promptly report boat damages and missing / damaged equipment to my assigned Adopt-a-Boat Fleet Coordinator.
